

Terms and Conditions

ALL Accor+ Explorer 1 Million Reward Points ("Promotion")

The following information on how to enter the Promotion and terms forms part of the terms and conditions of the Promotion ("Terms and Conditions"). Entries not made in accordance with these Terms and Conditions will be disqualified.

SECTION 1: PROMOTION

- 1.1 Promoter: AAPC Singapore Pte Ltd (ABN 58 805 288 553), a company incorporated under the laws of Singapore, having its registered office at 1 Wallich Street, Guoco Tower #17-01, Singapore 078881.
- 1.2 Promotion Period: The Promotion will commence on 4 November 2025 at 00:01 AM AEDT and will close on 4 December 2025 at 11:59 PM AEDT.
- 1.3 Entries received before or after the Promotion Period will not be accepted. All times recorded throughout these Terms and Conditions are in Australian Eastern Daylight (AEDT).
- 1.4 Participating Markets: The Promotion is open to eligible participants in the following markets: Australia, New Zealand, Singapore, Philippines, Indonesia, and India (collectively, the "Participating Markets").
- 1.5 Number of Winners: There will be a total of six (6) winners, with one (1) winner drawn per Participating Market.

SECTION 2: ELIGIBILITY

- 2.1 To be eligible to participate in the Promotion, during the Promotion Period, participants must be:
- 2.2 A new ALL Accor+ Explorer subscription member who joins between 4th Nov and 4th Dec, with the membership purchased through one of the following channels:
 - Online Public web registration page (ALL Accor+ Benefits Page)
 - Telesales
 - Hotel Sales
 - Member Services
- 2.3 Be a "new subscription member," defined as either:
 - (a) A first-time ALL Accor+ Explorer member with no prior transactions; or
 - (b) A returning member whose previous membership expired at least 31 days prior to the new purchase date.
- 2.4 Only successfully processed memberships are eligible. Complimentary memberships, free trials, and cancelled or refunded transactions are not valid and will be excluded from the Promotion.
- 2.5 Be a legal resident of the country in which the membership was purchased.
- 2.6 Be at least 18 years old; and
- 2.7 Not be excluded from participation under applicable laws in their country of residence.
- 2.8 The following categories of people are not eligible to receive the Prize and, if selected, will be disqualified:
 - Employees of the Promoter, Accor S.A., its affiliates, subsidiaries, or related entities;
 - Members who joined through Third-Party Corporate Partnerships;
 - Participants on Accor employee or friends/family rates; and



- Any other individuals directly involved in administering the Promotion.
- 2.9 This offer cannot be used in conjunction with any other offers or promotions.

SECTION 3: DETAILS OF THE DRAW

- 3.1 Each eligible membership purchase equals one (1) entry into the draw.
- 3.2 Duplicate entries from the same member or account, and entries arising from cancelled or refunded memberships, will be excluded.
- 3.3 Entries will be pooled by market, with one (1) winner per market drawn.
- 3.4 The ALL Accor+ Data Team will extract the list of eligible members.

SECTION 4: DRAWING THE WINNER

- 4.1 The draw will be conducted on **16 December 2025 at 2:00 PM AEDT** by the ALL Accor+ Explorer Data Team using **randomdraws.com**, a certified third-party random draw system. A Certificate of Random Draw will be produced as proof of compliance.
 - 4.1A Draw Details (Australia): For the purposes of compliance with Australian State and Territory requirements, the draw for the Australia winner will take place on 16 December 2025 at 2:00 PM AEDT at the offices of AAPC, Level 23, 1 Bligh St, Sydney, NSW, 2000, Australia
- 4.2 The draw will be conducted in accordance with all applicable local regulatory requirements in participating markets
- 4.3 One (1) winner per market will be selected by random draw from among eligible entries.
- 4.4 Replacement winners may be drawn if an original winner is disqualified, ineligible, or fails to claim the Prize as detailed in Section 5.

SECTION 5: WINNER NOTIFICATION AND VALIDATION

- 5.1 Winners will be notified via the email address registered in their membership profile on 17 December 2025.
- 5.2 The winner of the grand draw will be contacted by the local Accor Plus team via email and/or phone.
 - 5.2A (Australia only): Australian winners will have fourteen (14) calendar days from the date of notification to claim their Prize. All entries are subject to applicable state or territory legislation.
- 5.3 The list of confirmed winners will be published on the dedicated promotion landing page on the Accor Plus website within thirty (30) days of the draw.
 - 5.3A (Australia only): For Australian winners, the last name, first initial, and postcode will be published on <u>www.accorplus.com</u> within thirty (30) days of the prize draw in compliance with applicable state or territory legislation.
- 5.4 Failure to respond within the timeframe, bounced or undeliverable emails, inability to validate membership details, or inactive membership at the time of prize crediting will result in forfeiture of the Prize.
