

Terms and Conditions

ALL Accor+ Explorer 1 Million Reward Points ("Promotion")

The following information on how to enter the Promotion and terms forms part of the terms and conditions of the Promotion ("Terms and Conditions"). Entries not made in accordance with these Terms and Conditions will be disqualified.

SECTION 1: PROMOTION

- 1.1 Promoter: AAPC Singapore Pte Ltd, a company incorporated under the laws of Singapore, having its registered office at 1 Wallich Street, Guoco Tower #17-01, Singapore 078881.
- 1.2 Promotion Period: The Promotion will commence on 4 November 2025 at 12:00AM Philippine Standard Time and will close on 4 December 2025 at 8:59 PM Philippine Standard Time.
- 1.3 Entries received before or after the Promotion Period will not be accepted.
- 1.4 Participating Market: This campaign is limited only to Philippine participants only.
- 1.5 Number of Winners: There will only be one (1) winner for the market Philippines

SECTION 2: ELIGIBILITY

- Member Services: Membership purchased in person at the ALL Accor+ Member Care office located at Unit 102 CTC Bldg, Roxas Blvd, Pasay City, 1300, Philippines.
- 2.2A. Registration Details and Confirmation:

During registration, participants must provide their full name, valid email address, contact number, and payment details as required to process the membership purchase. After successful submission and payment confirmation, a confirmation email will be sent automatically to the registered email address to acknowledge successful registration and entry into the Promotion.

2.2B Frequency of Participation:

Each valid and successfully processed new membership purchase counts as one (1) raffle entry. Participants may purchase multiple memberships; however, only one (1) prize may be won per participant during the entire Promotion Period. Duplicate or fraudulent entries will be disqualified.

- 2.4 Be a "new subscription member," defined as either:
 - (a) A first-time ALL Accor+ Explorer member with no prior transactions; or

- 2.6 Be a legal resident of the country in which the membership was purchased. For the Philippines, participation in the Promotion is limited to Philippine residents only.
- 2.7 Be at least 18 years old; and
- 2.8 Not be excluded from participation under applicable laws in their country of residence.
- 2.9 The following categories of people are not eligible to receive the Prize and, if selected, will be disqualified:
 - Employees of the Promoter, Accor S.A., its affiliates, subsidiaries, or related entities;
 - Members who joined through Third-Party Corporate Partnerships;

SECTION 3: DETAILS OF THE DRAW

- 3.1 Each eligible membership purchase equals one (1) entry into the draw.
- 3.2 Duplicate entries from the same member or account, and entries arising from cancelled or refunded memberships, will be excluded.
- 3.3 The ALL Accor+ Data Team will extract the list of eligible members.



SECTION 4: DRAWING THE WINNER

- 4.1 The draw will be conducted on 16 December 2025 at 11:00 AM Philippine Standard Time at ALL Accor+ office located at Unit 102 CTC Bldg, Roxas Blvd, Pasay City, 1300, Philippines by the ALL Accor+ Data Team using randomdraws.com, a certified third-party random draw system. A Certificate of Random Draw will be produced as proof of compliance. The draw for the Philippine winner shall be conducted under the supervision of a DTI representative in the Philippines.
- 4.2 The draw shall be conducted in accordance with the rules and regulations of the Department of Trade and Industry (DTI) and under the supervision of its duly authorized representative.
- 4.3 One (1) winner per market will be selected by random draw from among eligible entries.
- 4.4 In the event the original winner is disqualified, ineligible, or fails to claim the prize, a redraw will be held.

SECTION 5: WINNER NOTIFICATION AND VALIDATION
